Grounds:

Staff of the Authority will seek an extension of the Temporary Order based on the following facts:

1. The Director issued the Temporary Order ordering, among other things, that the exemptions in Saskatchewan securities laws do not apply to the Respondent and that the Respondent cease trading in securities in Saskatchewan up to and including March 26, 2013;

- 2. The Temporary Order was issued without notice to the Respondent because the length of time required to hold a hearing would be prejudicial to the public interest;
- 3. No written request to review the Temporary Order has been made by the Respondent;
- 4. On March 22, 2013 and September 25, 2013 the Authority issued subsequent Orders (the Extending Orders), each time ordering that the Temporary Order be extended. As per the Extending Order issued September 25, 2013, which was issued with the consent of the Respondent's counsel, the Temporary Order was extended to the end of the day on April 1, 2014, unless the Authority made a further Order in the matter.
- 5. The Authority has not made a further Order in this matter.
- 6. It is necessary to extend the Temporary Order until the end of the day on October 1, 2014 in order to permit Staff of the Authority to finalize and serve the Statement of Allegations of the Staff of the Authority, set a hearing date and prepare documents and witnesses for the hearing.
